
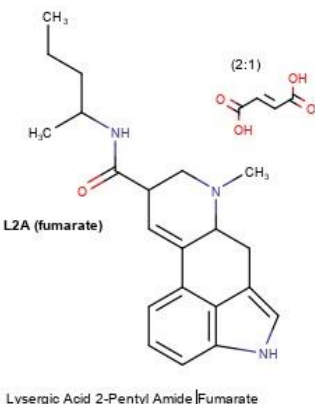

## SECTION 2 — HAZARD IDENTIFICATION

### 2.1 Classification of the substance or mixture

### SECTION 4 — FIRST AID MEASURES

#### General advice:

### SECTION 6 — ACCIDENTAL RELEASE MEASURES

#### Precautions for safe handling

Keep container tightly closed in a dry and well-ventilated place away from incompatible chemicals. Recommended storage temperature: <10 °C

#### Respiratory protection
